RE: RFP for Iron Fence at Capitol Hill and Trinidad Campuses

Attention Interested Parties:

Center City PCS would like to engage a contractor to fabricate and install an iron or solid iron composite fence at two school campuses.

Background on Center City PCS:

Center City Public Charter Schools, Inc. operates six charter school campuses in the District of Columbia. Each campus serves approximately 225 PreK to 8<sup>th</sup> grade students (250 students at capacity). The school buildings are leased.

Campus/Site Information:

Center City Public Charter Schools Capitol Hill campus is located at 1503 East Capitol Street, SE and the Trinidad campus is located at 1217 West Virginia Ave, NE.

Please Submit Proposals for the following projects:

## Project 1 - Capitol Hill:

- Remove and dispose of existing chain link fence along front and side of school building (front alley side/East Capitol Street SE/15<sup>th</sup> Street SE). Chain link fence around parking lot should NOT be removed.
- Fabricate and install new 4-foot iron or solid iron composite fence along front and side
  of school building (front alley side/East Capitol Street SE/15<sup>th</sup> Street SE). Fence
  should be black, to match existing fence surrounding school playground. Chain
  link fence around parking lot should NOT be replaced.
- Fabricate and install entrance gate(s) to the front yard (same location as existing entrance).

## **Project 2 - Trinidad:**

- Remove and dispose of existing chain link fence along front and side of school building (West Virginia Avenue NE and Neal Street NE).
- Fabricate and install new 4-foot iron or solid iron composite fence along front and side of school building (West Virginia Avenue NE and Neal Street NE). Fence should



be black, to match existing fence surrounding school field and parking lot.

## **Proposal Requirements:**

- 1. Firms or individuals should provide a proposal for both projects listed above
- Firms or individuals should be licensed to work in the District of Columbia
- 3. Proposal must include a cost estimate
- 4. Proposal must include an estimate as to how long the project will take, including any additional time necessary to order materials
- 5. Bidders must include at least two references, one of which must be a school

## **Proposal Process:**
